Community Garden to reopen in March

Local residents with green thumbs but no growing space can now rent a small patch of ground on lower Washington Street where they can cultivate to their hearts' content.

The Calistoga Community Garden is set to open at its new location this spring with more than half of its plots available for local gardeners to claim.

The garden plots can be used to grow all manner of fruits and vegeta-

bles, as well as flowers, CCG board president Brian Fennen said this week.

"People grow a little bit of everything," he said. "It's a fun hobby."

Of the garden's 46 plots, 26 are available to rent, said Fennen, noting that while some plots will be ready for gardening on March 15, others will come online gradually as there remains some work to be done, including grading and planter bed installation.

Fennen said that after the Community Garden was displaced

from its original location near the Calistoga Community Pool at Logvy Park in 2016, some gardeners relinquished their plots and will not be re-renting them, making them available for the first time in several years without a waitlist.

The cost to rent a garden plot is a one-time fee of \$50 and an additional \$50 to \$75 annual fee, depending on the plot size, which are available in two dimensions: 10-by-10 feet or

Inspectors: PG&E not to blame for 2017 Tubbs Fire

■ Point of origin linked to private electrical equipment at residence on Bennett Lane

PG&E equipment did not spark the deadly Tubbs Fire, which started near a private home just three miles north of Calistoga on Oct. 8, 2017.

Instead, Cal Fire investigators said in a report issued this week, it was privately owned and installed electrical equipment that likely served as the ignition point of the fire, which ultimately burned 36,807 acres in both Napa and Sonoma counties, destroyed 4,651 homes and killed 22 people.

"After a thorough, systematic investigation, taking into account witness statements, opinions of experts, physical evidence, collected electronic data, and fire direction indicators, the [Specific Origin Area] of the

School shooting threat is under investigation

Calistoga Police are investigating an alleged shooting threat that occurred at Calistoga High School Monday afternoon.

Sgt. Tim Martin said officers were called to the Lake Street campus around noon by school administrators, who became aware of the threat after a student posted pictures on social media of two messages


written on the wall of a boys' bathroom that read, "I will shoot up the school," and "gonna shoot the school."

A picture of a gun was drawn alongside the messages, Martin said. The student later deleted the social media post.

Classes were in session and continued without incident. Officers remained on campus for the remainder of the

Full-time code enforcement officer on the hunt for violators

For the first time, the city has hired a full-time code enforcement officer with the intention of making Calistoga a less complaint-driven community and more proactive in addressing violations.

Kelley Bird began the job on Sept. 24, and has since been actively addressing issues of health and safety, nuisance, and quality of life, said her supervisor police chief Mitch Celaya.

"We're addressing things in a more timely fashion and we're actively looking, where in the past without a full-time officer, we weren't consistently enforcing the rules," Celaya said this week.

As part of her job requirements, Bird monitors and enforces all city ordinances, codes and regulations related to zoning, land use, nuisance abatement, housing, health and safety, blight, graffiti, water waste and more. Her role also includes "code inspections, investigations, and enforcement related to business permits and operation of businesses, including vacation rentals, cannabis cultivation, manufacturing, testing, dispensaries and distribution," according to the job description created by the city.

"It's quite the spectrum of duties she has," Celaya said, noting that Bird works closely with members of several

city departments, including fire, planning and building, and public works, although she is technically employed in the police department.

Bird must also serve as an “objective third party” helping to mediate neighbor disputes, Celaya said.

“The city is being a lot more proactive. Our goal and priority is to gain compliance,” Celaya said.

When a violation is found or reported, Bird will first issue a verbal warning notifying the violator that a correction must be made. If the violation is not addressed, she will send a written notice of violation, explaining the problem, how to fix it, potential consequences and a time-line for correction.

“We try to work with people to get it resolved,” Celaya said.

City manager Dylan Feik said he and his staff saw a need for a full-time code enforcement officer, as the previous part-time person in that position often had to shift duties and cover as a police dispatcher. He and Celaya then approached the City Council for approval of the position and the budget to cover it. The cost they said would be \$106,815.

“Obviously, public health and safety code enforcement is first and foremost, but then when you get into the nuisance issues, quality of life impact, that has a lot of bearing on a community’s character, morale and attitude,” mayor Chris Canning said during a Dec. 4 council meeting when Celaya introduced Bird as a new employee.

According to Celaya, Bird possesses a Code Enforcement I Officer certificate and an EMT certificate from the California Association of Code Enforcement Officers.

“It’s been an honor being here with all of you in Calistoga. It’s a great little community, very family-oriented, and I’m happy to be here,” Bird told council members at the December meeting. “It’s been a great experience to get to know the culture. There’s a lot of history and a lot of amazing people.”

The news at Tuesday night’s annual membership meeting of the Calistoga Chamber of Commerce was motly swift and upbeat. New chamber CEO Troy Campbell, chair Laura Swanton and treasurer Leonard LaBranche presented a clear, swift accounting of the business world here in the best part of the Napa Valley. It is a healthy picture. In 2010 the chamber was \$50,000 in debt; today, it has an admirable \$410,000 in assets and 347 members. “I’m just happy I followed Chris Canning,” joked a smiling Campbell to laughter.

In the same period, 2010 to 2018, revenues from TOT, the transient occupancy tax, has more than doubled from its \$300,000 base, as has the two percent TID, tourism industry district self-imposed fee per room tax, now collecting \$265,00 a year. The TID helps fund things like the Calistoga Visitor Shuttle, Napa Valley Vine Trail, Arts in April, Fourth of July Fireworks, and much more. In a visitor destination marketing campaign funded by the city, the chamber also puts on the Lighted Tractor Parade, Concerts in the Park, Calistoga Holiday Village, Harvest Table and Arts in April. There are a lot more to list, but you get the gist. This not an uninvolved, inactive group.

There were a few other things I jotted down to pass on to you: the Amy Poehler, Tina Fey, Maya Rudolph girlfriends’ road trip to Wine Country is expected to be releaed mid-May on Netflix.

As for visitors, U.S. residents came from all over (except the Midwest) but the top states (excluding California) were New Jersey, Oregon, Minnesota, Florida, Washington and Arizona.

Barretts’ Land Trust deal preserves rural property

Calistoga winemakers Bo and Heidi Barrett have donated a conservation easement on their property near Calistoga that will preserve its natural beauty indefinitely, the Land Trust of Napa County announced this week.

This latest donation marks the second time the Barretts have worked with the Land Trust on a conservation easement.

“The process is not complicated,” Bo Barrett said in a statement. “We did it in just a few weeks and now, the property is protected forever.

“We are happy to participate in protecting the scenic hillsides of Napa for future generations.”

Located just north of Chateau Montelena, this easement elimi-

nates all potential for development on the property, protecting both its natural and scenic values.

By partnering with the Land Trust in creating the conservation easement, the Barretts preserve the property in its natural state forever, while maintaining the land in private ownership.

“I want to thank Bo and Heidi Barrett for this generous easement donation,” said Doug Parker, CEO of the Land Trust. “The parcel abuts another easement that the Barretts previously donated. Together these two easements create over 100 acres of permanently protected land right next to the City of Calistoga’s 260-acre Kimball Reservoir property.”

The property also contains a ridge line that is visible from both Highway 128 and Highway 29, protecting a scenic backdrop above the valley.

10-by-20 feet. The fees include a garden bed and water, but gardeners are responsible for filling their beds with soil, connecting their beds to the main drip irrigation system, and other supplies.

A storage shed from the previous garden site will be moved to the new garden area for gardeners to be able to store their own tools. They may also borrow tools provided by Calistoga Community Garden.

Fennen said he set up the irrigation system in December, and the city, which partners with the CCG, will pay for the water and the electricity to run a water timer.

Calistoga Community Garden, incorporated in 2003, is a non-profit public benefit organization, which “provides low cost opportunities for members of the Calistoga community to engage in organic gardening,” Fennen said.

It offers space to those who live in town and don’t have a backyard, enough space or too many trees to garden at their home. At least eight of the 26 available plots will be reserved for low-income applicants, as requested by city officials, said Fennen.

Fennen said the city worked with the garden board of directors on finding the new garden location, and then removed debris, brought in dirt to level the ground and added fencing.

jardín es una tarifa única de \$ 50 y una tarifa anual adicional de \$ 50 a \$ 75, según el tamaño de la parcela, que está disponible en dos dimensiones: 10 por 10 pies o 10 por 20 pies . Las tarifas incluyen una cama de jardín y agua, pero los jardineros son responsables de llenar sus camas con tierra, conectar sus camas al sistema principal de riego por goteo y otros suministros.

Un cobertizo de almacenamiento del sitio del jardín anterior se trasladará a la nueva área del jardín para que los jardineros puedan almacenar sus propias herramientas. También pueden tomar prestadas herramientas proporcionadas por el Jardín Comunitario.

Fennen dijo que estableció el sistema de riego en diciembre, y la ciudad, que se asocia con el CCG, pagará el agua y la electricidad para hacer funcionar un minuterio de agua.

El Jardín Comunitario, incorporada en 2003, es una orga-

nización sin fines de lucro de beneficio público, que “brinda oportunidades de bajo costo para que los miembros de la comunidad de Calistoga se involucren en la jardinería orgánica”, dijo Fennen.

Ofrece espacio para aquellos que viven en la ciudad y no tienen un patio trasero, suficiente espacio o demasiados árboles para cultivar en su casa. Al menos ocho de las 26 parcelas disponibles se reservarán para solicitantes de bajos ingresos, según lo solicitado por los funcionarios de la ciudad, dijo Fennen.

Incendio de Tubbs está cerca de la estructura residencial primaria y del área inmediata que rodea “La estructura en 1128 Bennett Lane”, escribió el jefe del batallón de Cal Fire e investigador principal, John Martinez, en el informe de 80 páginas.

El tan esperado hallazgo fue un golpe para miles de víctimas de incendios que desde entonces han demandado a PG&E con la esperanza de recuperar algunas de sus pérdidas. PG&E, que siguió a lo largo de esta semana en su decisión de solicitar la protección por bancarrota, había declarado solo un mes después del incendio de Tubbs que el incendio había comenzado con un equipo eléctrico que era propiedad de un tercero, instalado y mantenido.

A pesar de un examen exhaustivo que comenzó mientras el Tubbs Fire aún ardía, los investigadores no pudieron identificar el punto exacto de ignición en el equipo eléctrico privado o determinar qué pudo haberlo encendido debido a que la mayoría de las pruebas se destruyeron en el incendio.

Pero en el informe, Martínez descartó explícitamente las líneas y postes de PG&E que suministraban energía a la propiedad como fuente de ignición del incendio. Los investigadores usaron declaraciones de testigos oculares y estudiaron patrones de quemaduras, datos electrónicos y evidencia física en la escena para sacar sus conclusiones.

“Durante mi investigación, eliminé todas las otras causas del incendio de Tubbs, con la excepción de un incendio eléctrico provocado por un evento desconocido que afectó a un conductor o equipo de propiedad privada”, escribió Martínez.

La propiedad de 10 acres es propiedad de Ann Zink, de 91 años, quien ahora vive en la comunidad

de Indian Wells en el sur de California. La noche del incendio no había nadie en la casa de tres habitaciones en la propiedad, pero el informe de Cal Fire nombró a Mike Andrews como el cuidador contratado por la familia Zink para ayudar a mantenerlo.

Según el informe, Andrews caminó por la propiedad con los investigadores para ayudarlos a identificar dónde se habían ubicado las estructuras, que incluían el hogar, una bodega separada, una piscina y un garaje independiente - antes del incendio.

Los investigadores dijeron que PG&E entregó electricidad a la propiedad a través de un cabezal meteorológico en el techo de la residencia.

“Desde allí, el conducto exterior se conecta al medidor”, escribió Martínez. “Desde el medidor, el conducto lleva el conductor a un poste eléctrico de propiedad privada (polo privado 3). Desde el polo privado 3, el conductor se extiende hacia el noroeste hacia la bodega y el patio de la piscina.

“Además, desde el polo 3 privado, el conductor se extiende hacia el sureste hacia el polo 2 privado, luego al polo 1 privado donde se ubican los tanques de agua y la estación de bombeo”, continuó. “Desde el polo privado 1, el conductor se extiende cuesta abajo donde se une a un pozo junto a Bennett Lane”.

El informe no indica quién instaló el equipo eléctrico de propiedad privada y no se encontraron violaciones de la ley estatal.

Hasta la semana pasada, el Incendio de Tubbs fue el único incendio forestal importante en el Norte de California 2017 en el que no se identificó una causa. Sin embargo, Cal Fire ha encontrado que las líneas eléctricas de PG&E son responsables de al menos 12 de los incendios forestales de 2017 en el norte de California, y es probable que la compañía de servicios públicos también sea responsable de varios incendios 2018.

manufactura, pruebas, dispensarios y distribución”, según la descripción del puesto creado por la ciudad.

“Es todo el espectro de tareas que tiene”, dijo Celaya, señalando que Bird trabaja en estrecha colaboración con miembros de varios departamentos de la ciudad, incluidos incendios, planificación y construcción, y obras públicas, aunque técnicamente trabaja en el departamento de policía.

Bird también debe servir como un “tercero objetivo” que ayude a mediar en las disputas entre vecinos, dijo Celaya.

“La ciudad está siendo mucho más proactiva. Nuestro objetivo y prioridad es lograr el cumplimiento “, dijo Celaya.

Cuando se encuentra o se reporta una violación, Bird primero emitirá una advertencia verbal para notificar al infractor que se debe hacer una corrección. Si la violación no se resuelve, ella enviará un aviso por escrito de la violación, explicando el problema, cómo solucionarlo, las posibles consecuencias y un plazo para la corrección.

“Tratamos de trabajar con la gente para resolverlo”, dijo Celaya.

El gerente de la ciudad, Dylan Feik, dijo que él y su personal vieron la necesidad de un oficial de

Inspectores: PG&E no tiene la culpa del incendio de Tubbs

■ Punto de origen vinculado a equipo eléctrico privado en Bennett Lane

El equipo de PG&E no provocó el mortal incendio de Tubbs, que se cree que comenzó cerca de una casa privada a solo tres millas al norte de Calistoga el 8 de octubre de 2017. En lugar de eso, los investigadores de Cal Fire dijeron en un informe publicado esta semana, que era propiedad privada e instaló equipos eléctricos que probablemente sirvieron como punto de ignición del incendio, que

en última instancia quemó 36,807 acres en los condados de Napa y Sonoma, destruyó 4,651 casas y mató a 22 personas. “Después de una investigación exhaustiva y sistemática, teniendo en cuenta las declaraciones de los testigos, las opiniones de los expertos, las pruebas físicas, los datos electrónicos recopilados y los indicadores de dirección del incendio, el [Área de Origen Específica] del

Amenaza de tiroteo en la escuela bajo investigación


