# Residents question city's water, sewer rate hike plan

Calistoga residents worried about a plan to significantly raise water and sewer rates over the next five years told City Council members on Tuesday that they still have some explaining to do.

People have been talking, they said, since the Nov. 7 announcement by the council that water rates would climb 59 percent over five years while wastewater rates

would likely jump 36 percent in the same time period.

Since that meeting, the city mailed to every water customer a detailed report about why the increases are necessary as well as a notice that a public hearing on the matter is set for Jan. 2, 2018. In addition, posted on the city's website are several detailed documents prepared by the consultant hired more than a year ago to analyze the water and wastewater operations

and recommend ways to pay for

It's a lot of information and data to digest and there are conflicting interpretations among some of those trying to sort it out, said resident Karen Chang.

"I'm talking to people around town and they're saying one thing and I'm saying, 'No, that's not what I read," Chang told the council. "I

### School district refinances bonds, reports sound budget

Calistoga Joint Unified School District trustees voted this week to refinance \$8.5 million worth of general obligation bonds in order to take advantage of low rates and a program that would be eliminated under the Republican tax overhaul.

The move will save taxpayers an estimated \$2.2 million in coming years, district officials said.

"The sole intent is to benefit taxpayers," Paula Kleczkowski, executive assistant to superintendent Erin Smith-Hagberg, wrote in an email to the Tribune.

Refinancing the bonds, approved by voters in 2010 for new school facilities and upgrades, will not increase the term of the bonds nor will the district receive any cash as a

#### Council reseats Planning Commissioners, other representatives By Kim Beltran Mosquito Abatement Board of Trustees. Tribune Editor Valentine, who this year is serving as

Calistoga Planning Commissioners Tim Wilkes, Alissa McNair and Walter Abernathy were reappointed Tuesday night to their positions and will each serve another two-year term.

In addition, the Calistoga City Council also reappointed incumbents Dieter Deiss and Sophie Gullung to the Napa County Active Transportation Advisory Committee while naming newcomer John Gleazer to a third seat on the panel. All three will serve two year terms.

Shelby Valentine will remain the city's representative on the Napa County board president, will serve another two year term.

McNair and Wilkes are both architects. McNair was first appointed to the Planning Commission for a two-year term in 2015. She is actively involved with the Calistoga Rotary Club and Wine Country Animal Lovers pet rescue. She has lived in Calistoga for 36 years, according to the application she submitted for reappointment to the Planning Commission.

Wilkes, also an architect, has served on the Planning Commission since 2015

as well. He has lived in Calistoga for 27

Abernathy, a resident of Calistoga for eight years, is a retired executive director having worked at the Port of Oakland and Port of San Francisco. He has served on the planning commission since first being appointed in 2013.

A fourth applicant for one of three Planning Commission terms, general contractor Bob Branstad was thanked for his interest and asked to apply in the

The Active Transportation Advisory Committee, or ATAC, is an advisory committee of the Napa Valley Transportation Authority established by the NVTA Board of Directors to promote and encourage safe bicycling and walking. The committee works to further the Napa Valley goal of becoming more bicycle and pedestrian friendly along with promoting sustainable transportation alternatives. The ATAC focuses on countywide interests to reduce congestion and improve air quality by promoting non-motorized (biking and walking) transportation modes as a significant, safe and beneficial transportation
