John Merchant dies upon return from family vacation

■ Family members keeping details of longtime Calistoga businessman's death private

Resort owner and developer John Merchant, 75, passed away unexpectedly Tuesday after returning from a six-week vacation in Australia, family members confirmed on Wednesday.

Merchant's son, Danny, who worked alongside his father as a project manager at Indian Springs Resort, said the family had traveled to Australia for the holidays and that his parents had extended their stay after other family members had come home.

Danny Merchant said the family would not be releasing the details surrounding his father's death other than to say he had died from natural causes

John and Pat Merchant moved to Calistoga in 1988 after they purchased Pacheteau's Baths, the site of Sam Brannan's original resort. They rebuilt it into a luxury retreat and renamed it Indian Springs Resort. About the same time, the Calistoga Gliderport was also acquired by the Merchants after it had been operated by the Jim Indrebo family for more than a decade. John Merchant closed the gliderport in 1999 because it was financially challenging and regulations on small airports were tightening.

It was the beginning of a contentious time for John Merchant and city leaders who saw a newcomer holding a fair amount of downtown real estate begin pushing for change.

In 2005 after a fire destroyed part

City takes Grant St. property owners off hook for cost of path

■ Residents given options for repairing road, making it safer; asked to weigh in

Longtime plans to reconstruct a half-mile section of Grant Street inched forward this week when city officials presented concerned residents with four options for moving ahead with the \$1.3 million project

The addition of a five-foot wide asphalt pedestrian pathway on the west side of Grant appeared to be made more palatable to property owners when mayor Chris Canning informed them that the city would cover the cost of that installation.

That decision came on the heels of a community meeting last May that riled property owners along the route who, as a condition of their city-approved parcel maps, would be responsible for costs associated with constructing the pedestrian pathway. They argued that some of the so-called deferral agreements were decades old, unclear and unfair. Many contacted lawyers, and the project stalled as the city considered its next move.

On Wednesday, Canning told the 35 to 40 people

Planning commissioners will hold a second public hearing on Wednesday to consider recommending to the City

Council that amendments be made to the Infrastructure Element of the General Plan.

Brannan Cottage Inn owners are seeking a "Determination of Public Convenience or Necessity" in order to be able to sell wine and beer to customers of Sam's General Store, recently opened at the inn offering coffee and natural soda drinks as well as pastries and other snacks.

Public convenience or necessity is a tool for local governments and communities to limit the issuance of new
