## Judge declares lawyer will pay city legal costs

■ Judge says lawyer acted “in bad faith”

A superior court judge found an attorney’s antics were “frivolous and in bad faith” when he drained city coffers by illegally serving a writ of execution June 18 at Westamerica bank and transferring \$575,228 into an escrow

account.

On Friday, July 17, Napa County Superior Court Judge Diane Price called William McKinnon’s actions “bad faith and frivolous” when he put a lien on the city’s two accounts and left a penny as the balance. Judge Price ruled that McKinnon will pay the city’s legal and administrative costs of \$19,436 to clear up the mess he caused.

## Supes will hear Reverie appeal filed by Diamond Mtn neighbor

■ George Caloyannidis pays \$1,400 for appeal

Permit modifications are on hold at Reverie Winery on Diamond Mountain Road as a formal appeal packet has been accepted and a date set for a hearing by the Napa County Board of Supervisors. Calistoga resident George Ca-

loyannidis submitted the necessary paper work July 14 and paid the nearly \$1,400 in fees to appeal the decision made by the Napa County Planning Commission on June 17 to grant Reverie most of the permit modifications requested.

“From here on, we have to get a date,” Caloyannidis, who has lived on Diamond Mountain Rd. for the past 16 years, said Tuesday regarding the possible appeal hearing.

Caloyannidis won’t have to wait any longer to hear if his packet was

accepted.

“The hearing is set for Oct. 6,” Supervising Planner Charlene Galina said Wednesday afternoon. She added that county staff are putting together a formal appeal packet that will be made available to the public.

Owner of Reverie, Norman Kiken, was granted the modifications to his winery only if he first conducted the necessary creek restoration that

## Report due soon on historic significance of railway tracks

## K. Casey critically injured in car accident

Devoted citizen, wife, and animal enthusiast and former Calistoga Planning Commissioner Kristin Casey, 68, was involved in a car crash Tuesday afternoon that left her in critical condition.

Director of Communications and Marketing at Queen of the Valley Hospital Vanessa deGier confirmed Wednesday afternoon that Casey was in critical condition but could not comment further on her injuries.

According to officials, shortly before 3 p.m. Tuesday afternoon, Casey was driving her 2007 silver Toyota Prius northbound on State Route 29 just north of Diamond Mountain Rd. when her car drifted off the east roadway edge and collided with a tree.

California Highway Patrol Public Information Officer Anna Paulson said in a report that it was unknown why the vehicle went off the road but people in a car behind her said there was no braking or slowing on Casey’s part.

Paulson said that Casey sustained severe head injuries and was transported to Queen of the Valley Hospital. She was taken off life support on Wednesday and remained unconscious. Late

Wednesday evening, Casey’s brother and sister-in-law arrived from Michigan and went directly to the hospital.

Those who know and love her say they are praying for her recovery. Many can’t find the words to express how they are feeling.

“I hope with all my strength that she recovers,” Planning Commission Chair Jeff Manfredi said after hearing the news of the crash. “It’s truly tragic.”

Casey is a dedicated member of the Calistoga community, not only for having served on the planning commission for 10 years but also for her constant work to support the Cal-

istoga Cat Action Team (CCAT), a nonprofit dedicated to helping homeless cats in and around Calistoga.

From Jan. 1997 through Dec. 2006, the Calistoga City Council appointed Casey to fill a seat for five consecutive terms on the city’s planning commission.

The respect of her colleagues and her natural skills as a facilitator quickly helped her become vice-chairperson of the commission in 1998, which she held for the majority of her term.

Casey played a significant role in numerous projects of interest to the community. One of the most important was the 2003 General Plan Update, which identifies the hopes and desires of the community and serves as Calistoga’s “con-

stitution” for growth and resource management into the year 2020.

She also assisted the community in the review and approval of countless other projects including the Formula Business Ordinance, the city’s Sign Ordinance, the development of the Growth Management System Ordinance and through her service on a subcommittee for the development of the Hotel/Condominium Ordinance.

She is also a licensed attorney who specializes in estate planning and elder law. Casey is married to retired elementary school teacher Carl Sherrill.

The couple’s close friends David Johnston and Rose LeClerc were with Sherrill while he was learning about Casey’s accident.

the commission said must be done before permits are issued.

That is all on hold until the appeal process is complete, Gallina said.

According to Caloyannidis, there are two main factors driving his motivation to file the appeal; one is factual, the other is ethical.

In his appeal submitted to the county clerk, Caloyannidis wrote that issuing a use permit to legalize uses that have been illegally initiated and maintained for years can adversely affect public welfare and also degrades the moral fabric of the community when the county by its own policy is unwilling to en-

force its own laws.

Caloyannidis asks the question, “How can the county issue permit modifications to past discrepancies?”

He added Reverie’s approval by the commission makes a mockery of CEQA by allowing illegal uses to continue unchecked by law enforcement.

Caloyannidis said that being Reverie’s neighbor has nothing to do with why he is filling the appeal.

“I would be equally passionate,” he said, adding that the issue is about public health, safety and the welfare of the community.

Attorney Scott Greenwood-Meinert, on behalf of Reverie, said that he and his staff are waiting for the appeal information submitted

by Caloyannidis to be made public in order to get the winery’s modifications upheld.

Greenwood-Meinert said he is the land use counsel for Reverie but has no input on transactions with possible buyers.

At the hearing, proponents and opponents of the appeal will be given an opportunity to express their reasons why the appeal should or should not be granted.

Following the conclusion of the hearing, the board can uphold, deny or modify the decision in question.

The decision made by the board will be final and conclusive.

The hearing by the Napa County Board of Supervisors regarding Reverie is scheduled for Oct. 6 at 9:30 a.m. at 1195 Third St. in Napa.

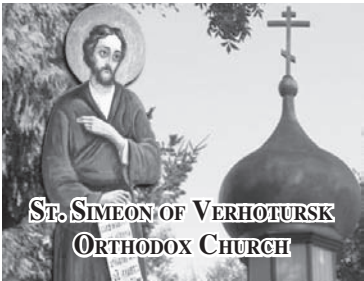

### Loss will greatly impact our town

We don’t know tonight, it’s Wednesday, what will happen to Kristin Casey, who was hospitalized with major injuries after her car veered off Highway 29 and hit a tree as she was driving back to Calistoga on Tuesday afternoon. The impact left her with severe head injuries that she was not expected to come back from, and family and friends, stunned by the news, did what they could to help.

We received a call from one of Kristin’s friends who wanted to make sure the cat colonies were fed, and did we know where the boxes are? Kristin kept the locations of some of her cat homes secret, and I wasn’t much help recounting where they might be.

I know one of them is right here at the Tribune office, because Kristin was here on Monday giving us instructions on how to get the feral cats that we feed treated for fleas.

Whenever we had a question or concern over the furry castaways she would respond with humor and confidence. One time, she was determined to catch a cat that we weren’t sure was fixed. She parked her car facing a cat trap she had set up in our parking lot. I don’t know how many hours she sat in the car watching for the cat to take the bait of canned food inside the humane trap, but she was one determined woman and the cat was caught.

Two years ago one of the feral cats came into the office late on deadline night. It looked and acted sick, and I really didn’t think it would live until the morning. I called Kritsin about 10 p.m. and she came wearing leather gloves from fingertip to elbow, crawled under a small table in the office supply room, grabbed the cat and was off to see Dr. Franquelin. A short time later she called to say Tabitha had to be put down because of a deadly virus she had that would contaminate the others.

Everytime we thought a cat needed to be looked at we called Kristin, and she always responded. She chided us to just feed kibbles and save money by not indulging in canned food.

Kristin was back again this week helping us with a black and white cat we call Baby Girl who was emaciated but ate like a truck driver. Turned out it was a horrible flea infestation, very treatable. She and Ellen were going to fetch the cat from Sally the Valley Vet on Tuesday, but Kristin didn’t show up to take Ellen with her and then we heard the news.

Everytime I feed a cat, I’ll think of Kristin, and remind the cats that they have lost a loyal defender of feral cat lives, and a woman whose dedication to them was immeasurable.

Streeter, First Appellate District Division IV) the Rancho de Calistoga Mobilehome Park’s general manager, Dean Mosher slapped us with a \$500.00 charge declared to be retro-active from Snowden’s conclusion to the then present time. They allowed this to be paid in a lump sum or at \$50.00 for ten months.

I chose the latter plan. In collaboration with other mobilehome residents I wrote “under protest” on my check for ten months. These were separate checks in addition to monthly rent payments, which were already reflecting the disputed increase that violated the amount allowed annually under CPI (Consumer Price Index).

After the ensuing years of hoping those two words would help us get that \$500.00 returned someday, will the State Court Judge’s decision implement that outcome?

The intention of this letter is not to review our plight here at Rancho so much, as to sincerely thank the City of Calistoga for upholding the RSO (Rent Stabilization Ordinance). I want to quote a message posted on the bulletin board in our mail room by a park resident this week, next to a cutout of your July 17 article: “Thank you, State Appeals Court, Thank you, City of Calistoga, and Thank you Michael von Loewenfeldt”.

Christmas in July? “The Bells of Christmas” is one of my favorite carols. If your readers will indulge a secular version brought to my mind as I read page one in last week’s Tribune: “–then pealed the bells more loved and deep, our attorney, von Loewenfeldt, has not been asleep...the wrong shall fail, the right prevail, with peace– here at 2412 Foothill Blvd”.

**HOT PICKLED BEANS**  
Hilary Prentiss, Angwin – Best of Show/Dorothy Bennett Memorial Award!

Green beans; garlic cloves, cayenne pepper, fresh dill or dill seed  
2 ½ cups white vinegar  
2 ½ cups water  
¼ cup pickling salt  
Pack each jar with: 1 clove of garlic, ¼ teas. Cayenne, one head fresh dill or teaspoon of dill seed and the green beans.  
Bring vinegar, water and pickling salt to boil on stove and pour over vegetable packed jars. Seal and process for 10 minutes in a boiling water bath. Store in a cool dark place for 1 month prior to opening.

**STRAWBERRY-BANANA JAM**  
Mary Ellen Hester via mother

Ellen Draney from Cranford, New Jersey – Second Place Winner!  
4 ¾ cups of prepared pulsed/mashed strawberries (about 2 quarts whole berries)  
3 fully ripe bananas mashed  
6 ¾ cups sugar  
3 T. lemon juice  
½ teas. butter  
Combine mashed bananas and strawberries. Stir in lemon juice, sugar and butter. Bring to a rolling boil on high. Stir constantly. Remove from heat and skim off foam. Fill jars up to an 1/8 of inch. Cover with lids and screw on closure. Process for 10 minutes in a boiling water bath.  
This is a good example of an experienced canner – Hilary, who also enters the California State Fair, winning three Blue Ribbons – Orange Marmalade, Dill Pickles and Hot Pickled Green Beans; two Seconds with Jalapeno Jelly and Apricot Butter. Plus a Third with Blueberry Apricot Jam. And a first time canner, Mary Ellen a winner with Second Place.

The San Francisco, Napa & Calistoga Railway began service to Napa on July 4, 1905, and started in Calistoga on September 2, 1908.

There are four criteria Evans will use in her evaluation and if the historical rails meet one of the four used for historic assessment, Evans will recommend mitigation, Goldberg said in an email to the Tribune.

The four criteria are:

1. It is associated with events or patterns of events that have made a significant contribution to the broad patterns of local or regional history, or the cultural heritage of California or the United States; or

2. It is associated with the lives of persons important to local, California, or national history; or

3. It embodies the distinctive characteristics of a type, period, region, or method of construction, or represents the work of a master, or possesses high artistic values; or

4. It has yielded, or has the potential to yield, information important to the prehistory or history of the local area, California, or the nation.

Last month Fire Chief Steve Campbell said he noticed that loose chunks of pavement were being displaced as their 37,000 pound engine was backing into the middle bay it occupies at Calistoga Fire House No. 1.

Campbell and public works director Mike Kirn took a closer look and agreed repairs needed to be made to remove the danger of a chunk of concrete flipping up and

damaging the undercarriage of the fire engine.

“It’s a matter of health and safety,” he said. Kirn said he thought the road, which still contains two rails embedded in the street from the old electric railway, was poured in the 1940s. The concrete is six inches thick. “Most roads are only good for 20-25 years,” Kirn said.

Kirn said workers would dig down 24 inches into the roadway and patch the area with 18 inches of base rock and then asphalt. The whole section of Washington Street will be replaced in the Fall at an estimated cost of \$675,000, Kirn said.

The terminus of the San Francisco, Napa Calistoga Railway track is still visible in the pavement on Washington Street. The railway depot was in the same spot as the firehouse is today. Kirn said

the rails would have to be removed when the street is reconstructed.

A historical marker across the street from the firehouse acknowledging the railway notes that the railway’s depot was built on the same spot as the station.

The rails are left over from the San Francisco, Napa & Calistoga Railway that operated until 1937. The line started in the port of Vallejo and terminated in Calistoga, a total of 41 miles.

Passenger service continued despite several setbacks until the ferry service was discontinued; without the ferry traffic, the line could not survive. The last passenger trains operated on Sept. 12 of that year, and the last mail trains on Sept. 30. On Feb. 13, 1938, a farewell excursion train ran between Vallejo and Napa for the Electric Railway Historical Society of California.

Crane topples at Troutdale bridge work site on Hwy 29

A crane operated by a Caltrans contractor toppled onto its side during construction work on the Troutdale bridge on Hwy 29 around 11 a.m. on July 15, reports Vince Jacala, Caltrans Public Information Officer, Napa and Solano Counties, District 4-Oakland. Jacala said the operator was inside the crane’s cab but was not hurt.

Caltrans is referring questions regarding the accident incident investigation to CalOsha. Crews were working to upright the crane as of 6 p.m., and had it cleared before nightfall.

Traffic on SR-29 was not being directly affected as the crane toppled away from the highway. However, some motorists slowed to watch as crews worked to upright the crane.

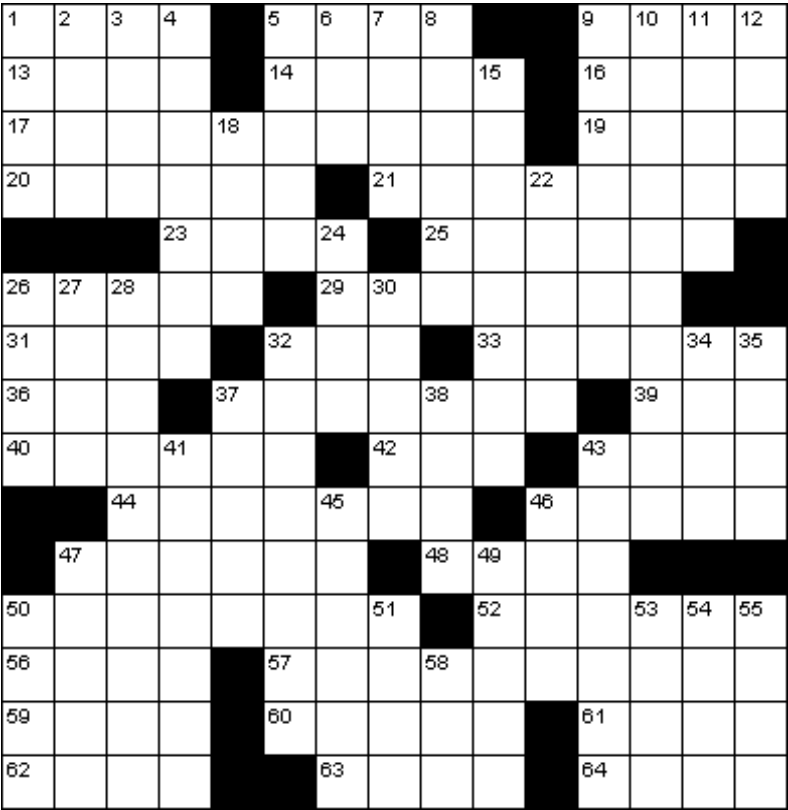

Trip to Lake Berryessa exhibit at Spanish Flat to learn about flood

On July 8, several Native Daughters from Calistoga Parlor No. 145 and two Native Sons from Calistoga Parlor No. 86 made a day trip to the Lake Berryessa Exhibit at Spanish Flat in Napa to learn how and why the town of Monticello was flooded.

The town of Monticello, in Napa County, once contained a

cemetery, a general store, blacksmith shops, hotels and various other businesses. In the late 19th century, the valley floor was covered with family farms. Much of the valley floor was covered with dry-farmed wheat and barley fields, with some orchards and grapevines. Ranching was mostly in the foothills.

Construction of a dam began in 1953. Vegetation in the valley was

chopped down, fences torn down and buildings burnt to their foundations. Three thousand people had to be relocated. The town cemetery was moved to Spanish Flat, a bluff overlooking the valley.

The Putah Creek Bridge, too well made to easily demolish, was left in place to be covered by the rising waters. Monticello Dam was completed in 1957, and Lake Berryessa was formed.

Virginia Dooley and her husband Jess were the last teachers to teach in the Monticello two room school. Virginia's class accommodated first through third graders, while Jess taught fourth to eighth graders. When they lost their home to Lake Berryessa, the Dooleys settled in Calistoga. Virginia has been a member of Calistoga Parlor No. 145 for twenty-five years and, at the age of 95, is still going strong.

McKinnon, who is the attorney for Grant Reynolds, a San Diego resident who has sued the city three times over water rights, fish habitat and Measure A expenditures, was awarded \$575,228 in attorney's fees on May 22.

On June 3 McKinnon recorded a judgement lien with the county recorder and on June 17, a Sheriff's deputy, at McKinnon's direction, served it to the Calistoga branch of Westamerica bank.

The law, Price noted, "clearly forbids the use of judgment liens or writs of execution against public entities" and that McKinnon should have known better. Sending an email to the City's counsel to ask for authority and then not responding to the City's counsel for four days demonstrated bad faith and was the sole cause for the fees and costs incurred by the City as it scrambled to rectify the emergency situation, Price said.

"Because the Court finds that Mr. McKinnon's actions were in bad faith and frivolous, Mr. McKinnon is hereby ordered to pay the City \$19,436.99." Price also ordered that the money be deducted from the amount the city owes McKinnon.

In his original request for attorney fees this past April, McKinnon asked for an award of \$1,017,887 plus an added multiplier of 2.75, for a grand total of \$2,799,189 in fees to be paid by the city. It was dismissed by Price.
