Montana couple buys entire inventory of local antiques store

Vice mayor Irais Lopez-Ortega was in court again last week to face the four felony charges of elder abuse filed against her by the Napa County District Attorney's Office in August of last year.



Monastery nuns gather local lavender plants to make essential oil, hydrosol

The sisters of the Holy Assumption Monastery are always up to something, whether it be administering to the sick and homeless, putting the finishing touches on new, wooden caskets or making cookies and granola to sell in their quaint gift shop/ bookstore on Washington Street.
