## City council serious about animal services

## ■ Letter in Tribune spurs action for contract

A recent letter to the editor helped spark the city council to address the lack of animal control services in Calistoga.

City council decided Tuesday evening to grant a 37-day continuance before deciding on whether to negotiate a professional services agreement with Napa County or Petaluma for animal control and shelter services.

Scott Atkinson of Wine Country Animal Lovers, Inc. (WCAL) and coordinator of Franquelin Dog Park addressed the board with concerns over Calistoga once again

working with the county of Napa for these services.

"We understand the need to act quickly because the City of Calistoga has been out of compliance for many years with state law regarding the issue of animal control service but there is time to make a correct, rational decision, not a quick one," Atkinson said Tues-

Calistoga resident Michelle Ortiz voiced her concern in Feb. about animal control in Calistoga after her Jack Russell terrier was fatally attacked in her yard by a neighbor's pit bull.

Ortiz said that after calling police she found that Calistoga does not currently contract with animal

## Library panel agrees with changes

■ Platform, shelves to be removed

The city council turned the final page on renovation of the Calistoga Library by unanimous vote Tuesday.

Napa County has \$651,908 in a fund for a new roof, change in the floor plan and new furniture at the city library. The proposal also calls for new entry doors for the Myrtle Street facility.

The changes also include removal of a small wooden platform and wooden book shelves, which Calistoga's library commissioner Shelby Valentine was against because of their historical nature.

The city's agreement with Napa County requires that city approval be given before major renovation takes place.

At last month's city council meeting, a Library Renovation Review Subcommittee was appointed to work with county librarian Danis Kreimeier to review the county's proposal and make recommendations. Appointed to the subcommittee were Ed Tapper, citizen-at-large; Michele Amendola, member of the Friends of the Library; and councilmember Jim

The subcommittee met on Feb. 10 to review public comments and draft a response of recommendations to the city council. In essence, the group agreed with the removal of the platform because "a platform is not necessary to perform library functions."

Removing the wooden shelves and replacing them with metal book shelves would make it easier for staff to use, the group offered. The group also suggested that part of the wooden book shelves in one area should be retained and used to hold special collections, such as the display of a rare Bible that belongs to the library.

"Overall, this process went very smoothly," Barnes told the city council Tuesday. "I think the plan is a good one."

Mayor Chris Canning asked Kreimeier if the directions from the subcommittee was clear, and she replied, "Pretty crystal clear."

The work on the library will be done this summer after the bidding process has played out and a contract signed.

The library will need a temporary home while the work is being carried out inside the building. It may be moved to the fairgrounds.

## Apartments project getting closer to opening doors

Calistoga Family Apartments are getting closer to opening the doors for families who qualify for residency.

The Calistoga Family Apartments will be limited to 48 families with at least one head-of-household employed in the agricultural industry because of federal financing restrictions, developers have told the city council.

The \$18 million project is being built by Corporation for Better Housing (CBH), a southern California non-profit firm that specializes in low-income housing projects. It was supposed to be finished in February, but hasn't completed driveways and off-site sidewalks said planning director Lynn Goldberg. Residents will go through a strict qualifications check, including income, criminal background, legal status and other benchmarks, Goldberg said, and that takes a lot of time to complete.

Goldberg said she thought the apartments would be ready to move into by the end of March.
