Candidates forum draws sparse crowd

■ Water, streets, budget topics for contenders

A sparse but interested audience listened to the three candidates vying for two city council seats on the Nov. 4 ballot as they offered opinions on a wide-ranging array of topics from economics to the drought, housing and a city mini-

mum wage.

Ballots for the upcoming election arrived in the mail this week for the 2,183 registered voters in the City of Calistoga as of Wednesday. Of those, 1,860 are permanent Vote By Mail (VBM) voters and 323 still go to a polling place to cast their ballots.

Napa County Registrar of Voters

John Tuteur has said that approximately 10 per cent of VBM voters will complete and mail their ballots within 7 days of receiving them and that about 75 per cent of VBM voters will complete and mail their ballots within 21 days of receiving them.

Of the five precincts in town, only one has a polling place open on election day (at the fire station) for casting ballots in person. How-

ever VBM ballots can be dropped off at the polling place. Monday is the last day to register for the Nov. 4 election.

Challenger Doug Cook sat between incumbents Jim Barnes and Gary Kraus in front of 26 people in the Community Center Tuesday night, the third and presumably last forum for this year's election.

Matthew Gudenius and his sixth-grade class work and learn on laptops in the classroom five days a week, and now the country is taking notice.

Calistoga Elementary was recently named a California Distinguished School, honored as a 2014 National Blue Ribbon School and now has a featured TIME news magazine article on store shelves.

The Oct. 20 edition of TIME due out Monday includes *The Paperless Classroom is Coming*, an article on the reality of the national push to get a computer into each student's hands and how it will change the way all American children are taught.

'It's a sweet little course'

"It's a sweet little course," said President Bill Clinton when he finished the first of two rounds of golf at Calistoga's nine-hole Mt. St. Helena Golf Course last Thursday.

Accompanied by Secret Service agents and a California Highway Patrol escort, Clinton's surprise visit to the clubhouse and course was at the invitation of supporter Vin Gupta of Yountville. Clinton shot a 39 in the first round and 40 on the second nine, posting a 79 on the par 68 course.

"There's plenty of trouble out there," Clinton told golf pro Kelly Hart and Mayor Chris Canning, who were waiting at the ninth hole, noting that the sixth hole was particularly challenging. "I could have used a five iron on the fifth hole to get out from under those trees."

'No Drugs Down the Drain' set for Oct. 18

The free collection of unwanted prescription and non-prescription drugs will take place tomorrow, Oct. 18, between 10 a.m. and 4 p.m. at the Calistoga Police Station, 1235 Washington Street,

across from Calistoga City Hall. As part of an ongoing effort to protect local waterways, marine life, and the people of Calistoga, Soroptimist International of Calistoga will be partnering with Calistoga Police Department and St. Helena Hospital for another free "No Drugs Down the Drain" collection.

Unwanted pet medications and used needles and lancets ("sharps") will also be accepted. Upper Valley Waste Management will be supplying free sharps collection containers. Controlled substances, such as prescription painkillers, are also allowed due to the Calistoga Police Department's presence.

The goal this year is to triple that amount by providing a book this fall, in the spring and at the end of the school year.


Reading helps children succeed academically which ultimately helps them succeed in life.



Police looking for witnesses of hit-and-run that hurt teen

Candidates have participated in two similar forums at the mobile home parks.

The reliance of city coffers on the tourism industry was a concern for all three candidates.

Economy

Cook said he the chamber has a big role to play in bringing new businesses to town and would like to see the city work hand in hand with the chamber to accomplish those goals. Kraus reminded listeners that Calistoga was founded as a tourist town by Sam Brannan and “that has always been in the background of our community.” He said downtown rents were high and demand limited, with a small population of shoppers, but “I think we’re making the best of it.” Barnes said the town should “play to its strength” and support the wine and tourism industries. “Take the money from the tourists and enhance our town. They go home every Sunday night and they leave a lot of money here,” Barnes said.

Income & Housing

Kraus said mid-income housing was a priority and that the “city has a housing problem.” He said he was open on discussing a city minimum wage and was willing to consider it if it were put up for a vote like San Francisco is doing.

Barnes said he would use the granny unit ordinance to help build second homes on lots zoned for a second unit to provide smaller, affordable housing. If a 1200 sq. ft home costs \$200,000 to build, about \$40,000 is in city fees. If the city puts that \$40,000 from its affordable housing fund into the general fund, the building cost would be reduced to \$140,000.

Cook said reducing fees could reduce the cost of homes, and affordability affects everyone. He said he would support looking at a housing allowance for city employees to live in town.

Minimum Wage

All three candidates were in favor of a higher minimum wage in the city but were cautious about saying how much it should be.

Water Supply/Drought

Cook said the city is within 18 months of running out of water and has attempted to get a report his supporters have drafted into

the newspapers but to no avail. Kraus said the water situation was critical but it wasn’t just a Calistoga problem, it was shared statewide. “There is absolutely no reason to think it will never rain again,” Kraus said. Barnes said he had read Cook’s water report and disagreed with the conclusions in it and that the city has made plans for an extended drought. “We’re taking all prudent measures and actions to safeguard the water we do have,” Barnes said.

Calistogans were entitled when their choice for council in the last election was denied.

Recalling my wife’s candidacy, I asked candidate Doug Cook: Would you appoint a candidate with different ideas to a vacant seat? He said he would respect the people’s vote and appoint the next highest vote getter. It is not a comment on the council’s eventual earnest appointees to note the difference between Cooke’s stance and councilman Kraus’s, who two years ago exercised his legal prerogative to ignore the popular vote, thereby abetting not healing but disillusionment.

It lingers. Last month, four different acquaintances brought up to me the topic of the last election and the “injustice” or unfairness suffered by Charlotte – and by extension, all those who voted for

her.

The point is not her history, but the sense of futility that Calistogans may suffer when their votes are rendered meaningless. More than water or housing, the problem is a fractured community’s sense of exclusion

Not everyone feels it. Partisans may belittle it. The mayoral fora (sic) may mollify it. But draw your social circle larger, and there it will be: the realization of a community still sadly divided.

I don’t agree with Doug Cook’s every idea. But he’s obviously an intelligent, independent thinker receptive to the diverse ideas that Calistogans offer – your ideas. He represents a new direction, a step toward reunification. Most important, on the fundamental issue of respectful inclusion of different perspectives, he gets it.

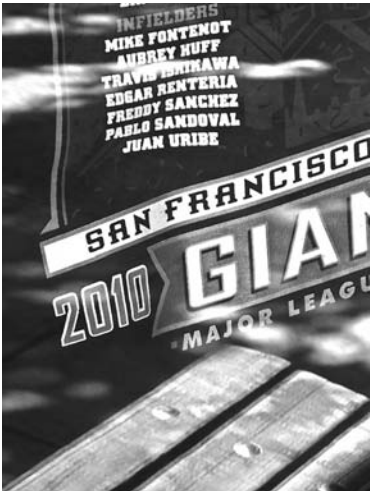

Coffee with a Cop provides a unique opportunity for community members to ask questions and learn more about the department’s work in Napa County and surrounding area, Sarnik said.

“The majority of contacts law enforcement has with the public happen during emergencies, or emotional situations. Those situa-

tions are not always the most effective times for relationship building with the community, and some community members may feel that officers are unapproachable on the street,” he said. Coffee with a Cop allows for a relaxed, one-on-one interaction, he said.

The program aims to advance the practice of community policing through improving relationships between officers and community members.

not just for the technology they use but for truly going paperless. He doesn’t use a single piece of paper in his class all year.

“It is exhilarating to have our students, teachers and the entire community be recognized for our work in a national publication as well as by the U.S. Department of Education,” Superintendent Esmeralda Mondragon said.

Working daily on individual computers for everything from math to social studies is not out of the ordinary for Calistoga’s sixth-grade classroom, but for many schools and parents across the nation, making the transition continues to be a battle.

“It’s always great when teachers, students, and schools are recognized and acknowledged for hard work and innovation. It was quite a surprise and an honor to be contacted out of the blue by Michael Scherer of TIME magazine,” Gudenius said.

Author Scherer points out in his article that President Obama announced a federal effort last year to get a laptop, tablet or smartphone into the hands of every student in the U.S. by 2017. Getting all 49.8 million American kids, parents and schools on the same page or even bandwidth hasn’t been easy.

Fortunately for Calistoga, voters in 2010 approved a \$42 million bond that financed improvements at the elementary and junior/senior high school, including modernizing computer networks.

The bond needed a 55 percent affirmative vote and passed with 62.9 percent.

Gudenius says that he is proud of the success that is occurring in Calistoga, despite challenges and the fact that the use and benefits of educational technology is not cut-and-dried, black-and-white.

“The use of technology is seamlessly infused in all classrooms and it is definitely an advantage to have early adaptors such as Mr. G among other teachers in the district who have and continue to lead the way and carry the torch,” Mondragon said.

Gudenius started at Calistoga Elementary as a computer-lab instructor before moving into his role as the tech-savvy sixth-grade teacher.

He says that whenever there is something as important to discuss as education, it’s essential to take a critical approach, to hear all sides and opinions, and always to ask why we are making the decisions that we do.

“It just gives some validation to the idea that innovating and trying new things is worthwhile, even if there are hurdles along the way, and we don’t know all of the answers or have the perfect recipe for success. That’s motivating and invigorating for myself and for my students,” Gudenius said.

Gudenius added that working with Scherer on the story was an unexpected experience that he won’t ever forget.

“My next step is to keep learning and keep trying to improve education, with whatever tools work best. Aside from my main teaching role, I am also developing some apps that I hope will greatly improve my experience as a teacher, as well as streamline teaching for other teachers,” Gudenius said.

The team garnered state wide attention and captured the hearts of the entire town when they took us on a magical seven week ride of emotion, pride, and enthusiasm while accumulating a 7-0 record and a No. 1 state small school ranking before a season ending injury to Shannon Blakeley was too much for the guys to overcome.
