Killer blaze forces evacuation of entire town

Residents roused at 3 a.m. by police, fire going door-to-door

When the knock came on their Foothill Boulevard door at 3:30 a.m. Wednesday, the Pedro Chavez family was ready to go.

Pedro's daughter, Genesis, had seen the flames of a large fire burning north of Calistoga while working Sunday night at the Calistoga Motor Lodge. She called home then and told her parents to pack a bag in case they had to leave. Then she began monitoring fire reports through social media, online news and Nixle alerts.

"We were among the first ones to leave," said Norma Edith Montero, whose family lives on West Myrtle Street off Foothill Boulevard and is friends with the Chavez's. "Cars were driving through the streets honking [to let other people know the town was being evacuated]. There was heavy traffic but it was moving fast."

The Tubbs Fire, as it is now known, had started late Sunday night north of Calistoga off Bennett Lane and Highway 128, according to officials, and in the span of eight hours had roared over the western hills into Santa Rosa, leaving widespread devastation in its wake.

But on Monday evening, a shift in the wind began pushing the fire to the northeast toward Mt. St. Helena.

Tubbs Fire death toll at 15; many missing

■ Mountain Home Ranch Road man among those killed as fire spread to S.R.

Calistoga resembled a ghost town early Wednesday night, its 5,000 residents evacuated because a massive, out-of-control wildfire burning to its north was threatening the city.

The Tubbs Fire, which started late Sunday evening near Highway 128 and Bennett Lane, had, in the span of eight hours, roared over the western hills into Santa Rosa, leaving widespread devastation in its wake.

As of Thursday night, the fire had consumed nearly 35,000 acres, killed 15 people – including one Calistoga man on Mountain Home Ranch Road – and was just 10 percent contained.

Mountain Home Ranch Road resident Michael John Dornbach, 57, was listed among those who died when the Tubbs Fire burned up and over the hill into Santa Rosa early Monday morning. Mountain Home Ranch Road is technically in Sonoma County but people living there have Calistoga addresses.

The other 14 people killed were from the Santa Rosa area, where entire subdivisions were reduced to ash.

The Sonoma County Sheriff's Office, which released the names of the dead on Thursday afternoon, said it had received 1,000 missing persons reports. Of those,

Feds approve some disaster funding

On Tuesday, President Donald Trump’s administration approved Federal Emergency Management Agency (FEMA) disaster funds for Categories A and B Public Assistance, which provides funding for “emergency work and the repair or replacement of disaster-damaged facilities” and debris removal.

Hazard mitigation was also approved. This is funding for local

communities to repair facilities in a way that will help make sure they are better able to withstand future fires.

“The approval of these federal disaster funds is an important step in our recovery,” Rep. Mike Thompson, D-St. Helena, said in a statement. “They will help our cities and towns repair the damage that these fires continue to inflict on our community.”

On Thursday, Thompson announced that the administration had also approved FEMA Indi-

vidual Assistance disaster relief for Sonoma County.

This money will bring relief to individuals and families who have lost homes and property in the fires to help them recover and rebuild.

“This approval of Individual Assistance is the first step on the long road to recovery for Sonoma County and will be a tremendous help to families who have lost everything,” said Thompson.

Earlier this week, the president declared the fires major disasters, allowing FEMA to provide emergency assistance for immediate logistical needs.

containers to transport the waste to the hospital’s incinerator.



Unprecedented air pollution from wildfires unhealthy for sensitive groups

The Bay Area Air Quality Management District issued a health advisory and Spare the Air Alert on Wednesday.

Very unhealthy air quality from the wildfires in the North Bay is causing unprecedented levels of air pollution throughout the Bay Area. Due to active wildfires and changing wind patterns, air quality could be impacted for many days to come.

“It is imperative that Bay Area residents protect their health, especially in Napa and Sonoma counties. If possible, it is recommended that residents impacted by heavy smoke seek shelter in buildings with filtered air or move to areas outside the region less impacted by wildfire smoke until smoke levels subside,” the statement read.

It is recommended that parents and school administrators check air quality readings before allowing children to practice outdoor sports while air quality is unhealthy. To check for real-time air quality readings, go to <https://go.usa.gov/xxnhb>.

Because of the serious air quality conditions in parts of the Bay Area, residents are asked to avoid adding additional air pollution by curtailing air polluting activities such as wood burning, lawn mowing and leaf blowing.

Smokey conditions can cause irritation of the eyes, nose and air passages. These conditions can be hazardous for sensitive individual including young children, the elderly, individuals with heart conditions, and those with chronic lung disease such as asthma, bronchitis, and other respiratory conditions.

Individuals with asthma, bronchitis, emphysema and other lung or heart diseases should carefully adhere to their medical treatment plans and maintain at least a five-day supply of prescribed medications. They should limit outdoor activity and unnecessary physical exertion. Air conditioning that recirculates indoor air should be used, when available. Drinking plenty of water to avoid drying of the airways is recommended, unless restricted for medical reasons.

Dust masks are not protective against the ultra fine particulate, which is the pollutant most detrimental to health caused by wildfire smoke. Air purifying respirators, such as N-95 filtering face pieces, may be effective in reducing some of the harmful particulate matter, but they also increase the work of breathing, can lead to physiologic stress, and are not recommended as a general protective measure.

The winds calmed on Tuesday but with night falling, they were forecast to start blowing again, this time to the southwest, meaning the flames would be pushed directly down the valley through Calistoga.

At 10:30 p.m. Calistoga officials, who'd been manning the city's Emergency Operations Center at the fire station since Sunday night, got a call from CalFire's Sonoma unit recommending that they evacuate the city.

"Using Nixle, we issued our first evacuation warning," said City Manager Dylan Feik in an email sent to the Tribune on Thursday.

"Everyone between Grant Street and Silverado Trail were mandatory evacuations; everyone between Grant and Foothill were advisory.

"We had to wake people up and even transport many of them," he added. "We completed door-to-door checks in under three hours and waited to decide on the next phase of evacuation."

Calistoga Police and Calistoga Fire personnel were assisted in the door-to-door notification by legions of officers from the Oakland Police Department, Napa County Sheriff's Office and Napa Police Department.

At 3 p.m. on Wednesday, the order went out -- mandatory evacuation for the rest of the city. By 5:30 p.m., Calistoga looked like a ghost town.

Many residents left the county altogether, bunking with friends or family members from Tahoe to Santa Cruz.

Those without any place to go ended up at an evacuation center set up at the American Canyon High School gym, some 36 miles to the south.

Others from Calistoga were being housed at the Napa Valley College gym in Napa where about 400 evacuees -- many refugees from the Atlas Peak and Patrick Road fires burning, respectively, in the east and west hills on either side of that city.

The Chavez and Montero families, along with friend Jose Montanez and about 20 members of his family, were at Napa Valley College, where the Red Cross was on scene as well as volunteers from all walks of life: nurses, veteran's groups and high school students.

At meal times, they said, various Napa restaurants would show up offering fresh, hot meals. There was also a store of food products available inside the gym for the anyone who asked -- sandwiches, cookies, chips, water, coffee and tea were plentiful.

Out in the packed parking lot, an impromptu donation center had sprung to life, thanks to a group of volunteers led by Kim Sykes of Napa. She'd gone out to the college around 9:30 a.m. to offer her services at the shelter and was told they were covered. As she was driving out, she noticed huge piles of clothing, shoes, sheets, blankets and more just being left by people wanting to help. She jumped in and began sorting everything by type and size. By 2 that afternoon, others who'd come to volunteer were directed to her area and were still sorting donations into boxes by gender and size. Evacuees were free to rummage through the boxes for whatever they needed.

Sitting in the parking lot with her family, her dog and her friends, Sylvia Chavez, a Calistoga resident for 33 years, was smiling. But recalling Wednesday morning's evacuation from her hometown she said, "It was very, very scary."

603 had been located. 400 people were still missing.

Like Dornbach, 81-year-old Tom Leonard and his family -- two elderly sisters, daughter, Lee, and granddaughter, Tully, -- as well as tenant Dianne Foster, were in their homes on Mountain Home Ranch Road when the fire came in the middle of the night.

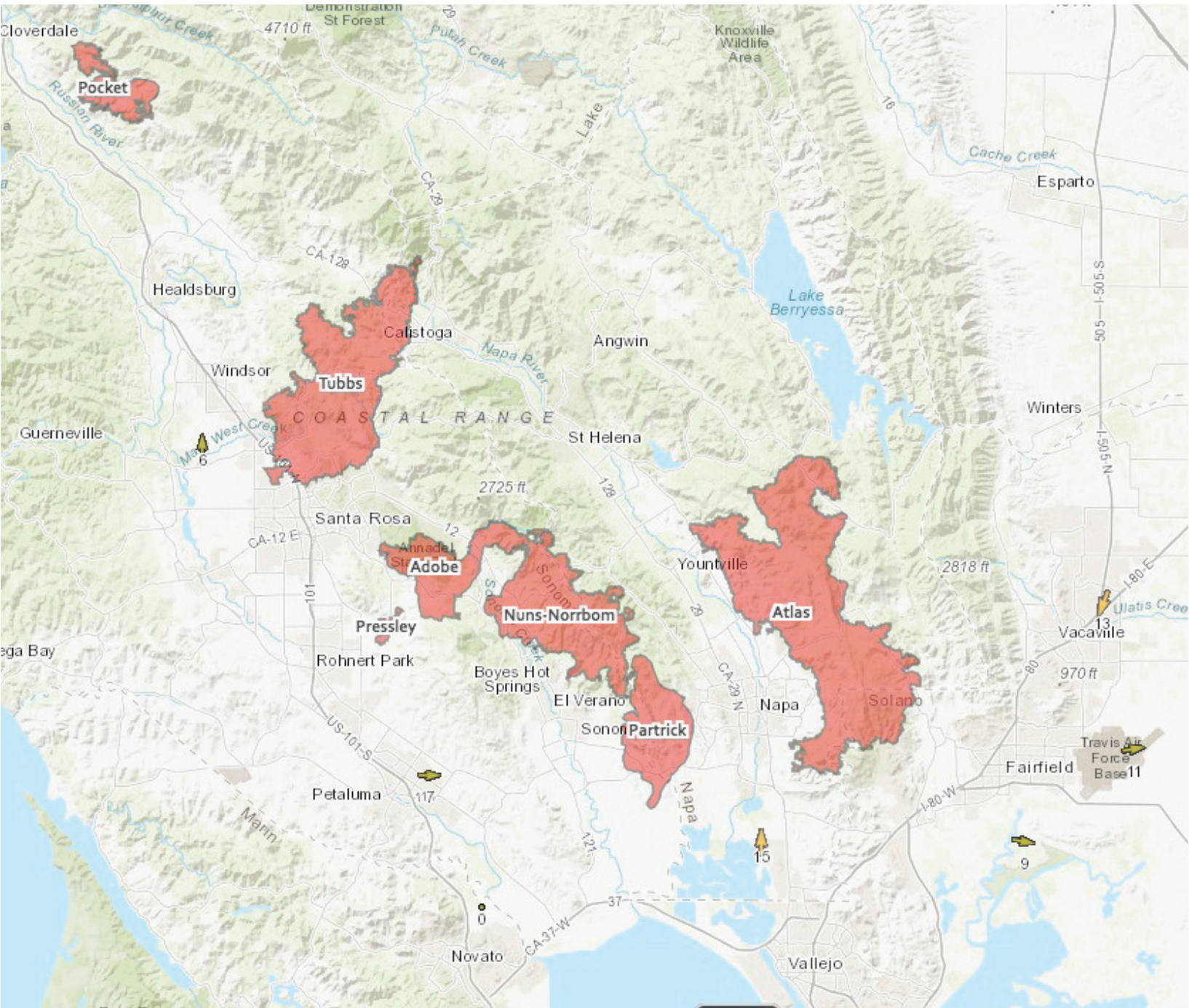
Seeing flames on the ridge behind their homes, they began loading some necessities in several vehicles to evacuate. Before they could get in the cars and drive out, the fire was upon them. They survived, along with five dogs and a cat, by jumping in their swimming pool, where they stayed for two hours as everything around them burned to the ground, including their five cars and their homes.

After the fire had passed through, two Sonoma County Fire personnel in SUVs came up the road looking for survivors and drove them out. Tom, Lee, Tully and Diane were brought to the Calistoga Fairgrounds, which had opened just after midnight as an evacuation center.

Guests staying at Calistoga Spa Hot Springs were evacuated to the fairgrounds at about the same time when a small grass fire broke out on lower Washington Street in the city limits. That fire, started when 50-mile-an-hour wind gusts knocked a tree into a power line, was quickly extinguished.

While the Tubbs fire on Thursday continued to burn in the north near Mt. St. Helena and in Sonoma County in northern Santa Rosa, firefighters from all over the state and from outside California as well were also battling several other large fires to the east, west and south of Napa County.

In Sonoma County to the east, the Adobe Fire was burning near the Annadel State Park and merging with the Nuns-Norrbom Fire west of Boyes Hot Springs. The Nuns-Norrbom Fire on Tuesday

Sonoma County Sheriff's Office said 400 people are still reported missing. The Atlas Peak Fire east and south of the city of Napa was the largest, having burned nearly 44,000 acres. It was seven percent contained as of Thursday night but still threatening parts of the city.

evening had burned up the mountain, forcing the evacuation of Mt. Veeder and threatening to come down the Oakville Grade into Napa County.

The Nuns Fire was also close to

merging with the Patrick Fire to its south. The Patrick Fire had started southwest of the city of Napa and burned through the Cameros region toward the town of Sonoma.

And, to the east of Napa, the massive Atlas Peak fire was burning from the southern end of Lake Berryessa to Green Valley in Solano County and Skyline Park on the outskirts of Napa behind the Napa

State Hospital. The Atlas Peak Fire on Monday had swept down Atlas Peak, forcing mandatory evacuations to the rural neighborhoods known as Monticello Park, Silverado Country Club and Circle Oaks. Evacuations were also ordered on Wild Horse Valley Road and Silverado Trail from Trancas Street to Highway 128 and Highway 128 to Moskowite Road.

In the early morning hours of

Monday, people living above the fire on Atlas Peak Road had to be rescued by helicopter as the flames burned below and blocked the only road in and out.

According to CalFire, as of Thursday, 21 fires burning in Northern California had charred a total of 191,000 acres. More than 1,300 personnel were working these fires, using eight air tankers, 17 helicopters and 131 engines.

Help comes from Oakland Police Dept.

Lt. Mike Reilly of the Oakland Police Department had a special reason for helping protect Calistoga this week.

He and his wife come to Calistoga almost monthly, he said, for the wine, people and restaurants.

“I’ve never come here without being treated well,” Reilly said Wednesday afternoon after meeting with Mayor Chris Canning. “My wife would not be happy if something happened here.”

Reilly was part of a large contingent of Oakland law enforcement personnel that responded to a mutual aid request by city officials when evacuation plans were being formed.

Reilly said the bay area department had already dispatched between 60 and 75 officers, including many from the motorcycle division, to help set up roadblocks and evacuate Calistoga’s 5,000 residents.

Response from local restaurants was heartwarming, Reilly said. His shift of officers and other

emergency personnel received an early morning breakfast of eggs, ham, and English muffins from Roger Dierkhising and his staff, at Cafe Saraformia.

“We tried to pay but they wouldn’t let us,” Reilly said. “When locals or tourists came in, they got free coffee. It was very generous.”

Setting up roadblocks to keep travelers out of deserted areas and from driving onto closed roads while exiting town are easy tasks for outside agencies, Reilly said. Local police would handle the downtown area and neighborhoods, especially those impacted by the two bridge construction projects.

Residents will return to find spray painted symbols on the street in front of their homes, said Mayor Chris Canning. Napa City Police, Napa County Sheriff’s, Napa County Probation also assisted Calistoga public works, police and fire personnel in visiting each home in Calistoga.

A check mark meant the house was visited and occupants told of the mandatory evacuation order; a circle indicated it was empty, and an X meant occupants refused to evacuate.






When several major wildfires began rapidly burning large swaths of land at both the north and south ends of the Napa Valley, it wasn't long before thousands of residents lost their ability to make calls on their cell phone calls.

In addition to knocking out electricity, the blazes reportedly damaged or destroyed 77 cellular sites, disrupting communication services throughout Napa and Sonoma Counties.

That's when many people turned to social media sites such as Twitter, Facebook and Nextdoor to communicate with family and friends. Internet, or WiFi, operates on a differnt system than cell towers, using a system of radio frequencies to transmit.


Text messaging was intermittent but many people continued to receive Nixle alerts -- official notifications from cities, counties and law enforcement agencies containing up-to-the-minute information about the fires, road closures and evacuations.

Here is a sampling of some of the social media notices Calistogans were using to communicate.


